An Invitation to the 1991 Officers Leadership Academy

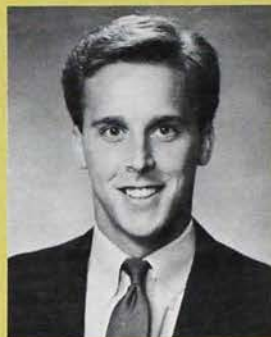
Dear Brothers:

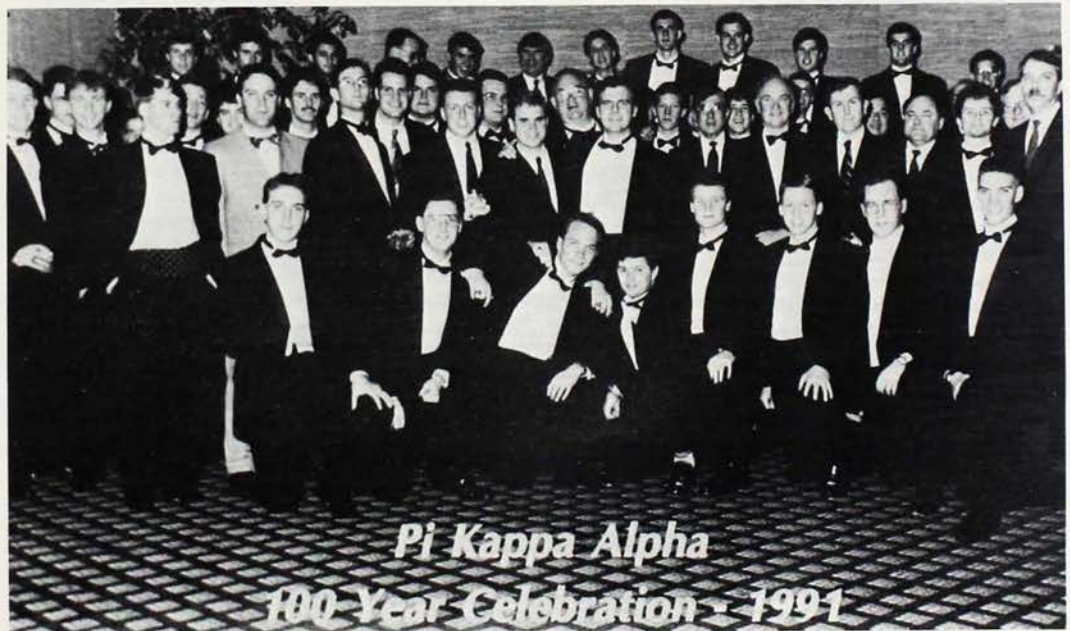

The Pi Kappa Alpha Educational Foundation's Order of West Range

A fitting tribute to men of uncommon excellence.

There is no checklist of qualifications for induction into the Order of West Range, the Pi Kappa Alpha Educational Foundation's highest honor. It is not enough to have senator or governor preceding your name, though many do. Nor is it enough to be called chairman of the board or president, though many are. Members of the Order have not only occupied positions of leadership in business, the Fraternity and federal, state or local government. These men have used their high offices, talents and influence to benefit their communities, their nation and their Fraternity.

To wear the medallion of the Order of West Range is to be honored and rewarded for a lifetime of achievement in many arenas, both personal and professional. The following brothers were inducted into the Order of West Range during the past academic year. Each man has brought great honor to Pi Kappa Alpha. Following their profiles is a preview of the gentlemen tapped for induction into the Order in the coming year.

PAUL G. BLOUNT

Epsilon Nu '60

"Dr. B" as he was known during his years at Georgia State University, came to Pi Kappa Alpha as a special dispensation initiate of Epsilon Nu Chapter at Georgia State University.

Although he was not a fraternity man during his undergraduate years at Westminster College, in his hometown of Fulton, Missouri, Dr. Blount served as the first advisor to the Pi Kappa Alpha Colony at Georgia State. When that Colony was installed in 1960, Dr. Blount was one of its charter initiates.

Just six years later, Dr. Blount was appointed national historian. Within two years of his appointment, Dr. Blount revised Freeman H. Hart's *History of Pi Kappa Alpha*, adding valuable material on the founders and junior founders, as well as an entirely new final chapter. Dr. Blount served

as national historian from 1965 until 1976. Dr. Blount also served as president of the Atlanta Alumni Association and the Fraternity's District #8.

In addition, Paul Blount left his mark on Georgia State University, as chairman of the English department and Regents Professor of English for over twenty years. He has been published in numerous learned journals and written a test for proficiency in English of freshman and sophomores after forty hours of academic study. Brother Blount also served on the blue-ribbon committee that developed University-system policy regarding tenure. He served as a consultant to the Department of Education as well.

Although "Dr. B" no longer advises or teaches English, his impact is still felt both in Epsilon Nu Chapter and at Georgia State University. As a tribute, an alumni group is forming a scholarship in his name, a special honor for a gentleman who has devoted his life to education and fraternity.

WILLIAM H. "BILLY" DIAL

Alpha Eta '27

Although he modestly dismisses accolades, Brother William Dial is considered "an original architect" of one of the most vibrant centers of commerce in the Southeast. Billy Dial came to Orlando, Florida in 1932 as a lawyer fresh out of the University of Florida's law school. He joined the firm of Akerman and Palmer. Twenty-six years later, Brother Dial retired from that firm, now known as Akerman, Dial and Akerman.

Retirement from the legal profession, though, did not mean retirement from the business community he adopted. Brother Dial immediately became executive vice president of the First National Bank of Orlando. Billy's involvement with First National began when he assisted in its formation in the early 1930s. Opening its doors in 1934, the bank named Billy its attorney

shortly thereafter. In 1945 Billy was elected to its board of directors. This was only the beginning of Brother Dial's relationship with the First National Bank of Orlando. In 1961 he was appointed president of the bank. As president he launched an effort to establish a major bank-holding company. His efforts paid off in 1967 when First at Orlando began operating. Dial was the appointed president and chairman of the five-bank holding company, which was renamed Sun Banks of Florida, Inc. in 1973. Brother Billy Dial, who is considered one of the five most important leaders of Central Florida retired from banking in 1977.

Brother Dial was instrumental in bringing Walt Disney World to Orlando. Disney's former president and chairman, Donn B. Tatum, described Brother Dial best when he said, "Billy enjoys life and other people, and they enjoy him. Absolute integrity is the best way to sum him up. You can always rely on his word without question."

Pi Kappa Alpha has benefited a great deal from the Dial family. Billy served Alpha Eta Chapter at the University of Florida as SMC in 1929. His brother, the late John Dial, was also an important member of Alpha Eta Chapter, purchasing the property for the original Alpha Eta house. The Dial legacy continues in his grandson, William Ruffier, who served Sigma Chapter as ThC in 1990-1991.

FRANK SINKWICH

Alpha Mu '41

Few men have meant as much to a State, a University and a Fraternity as Frank Sinkwich. A 1943 initiate of Alpha Mu Chapter at the University of Georgia, Brother Sinkwich was Georgia's first Heisman Trophy winner and the only Pike

to ever receive that high honor. In 1941, Brother Sinkwich was a unanimous All-American selection after setting an SEC rushing record that would last eight years. That season Brother Sinkwich led Georgia to a 40-26 victory over TCU in the Orange Bowl. His performance during that game was considered the greatest bowl performance of all time. He gained 139 yards rushing and completed nine of thirteen passes for 243 yards and three touchdowns.

Described in the January 1943 issue of the *Shield & Diamond* as the "flat-footed fireball of Georgia", Brother Sinkwich was named captain of the 1942 Pi Kappa Alpha All-American team. During that season, Brother Sinkwich, as captain of the Georgia Bulldogs, led his team to an SEC Championship and a 9-0 Rose Bowl victory over UCLA. Along the way he set an SEC passing record. Brother Sinkwich capped his college football career with an SEC total offense record and the 1942 Heisman Trophy as the Nation's outstanding player.

Although a knee injury cut short his professional career, Brother Sinkwich was an All-Pro selection with the Detroit Tigers in 1943-44.

Brother Sinkwich, who was inducted into the College Football Hall of Fame in 1954, is an important part of the history of the University of Georgia and Pi Kappa Alpha. Brother Sinkwich's posthumous induction into the Order of West Range was a fitting token of the Foundation's respect and appreciation for him. Shortly after Brother Sinkwich's death, Georgia Athletic Director Vince Dooley said, "We have lost one of the great legends of college football history." In recognition of his achievements, Brother Sinkwich's Order of West Range medallion was presented to his daughter during the Atlanta Area Alumni Club's Founder's Day.

ELBERT P. TUTTLE

Beta Theta '16

Judge Elbert P. Tuttle has never backed down from a challenge. Whether he was leading Pi Kappa Alpha through the tumultuous National Convention at Troutdale in 1933, participating in the Okinawa campaign during World War II, or rendering landmark decisions in the civil rights cases of the 1960s as a U.S. Circuit Judge, Brother Tuttle has led with great integrity, courage and character.

As a charter member of Beta Theta Chapter at Cornell University, Brother Tuttle represented his chapter at the 1917 National Convention. Slightly more than fifteen years later in 1933, he became Pi Kappa Alpha's national president. At the National Convention in Troutdale, Brother Tuttle directed the most comprehensive reorganization of the Fraternity since the refounding in 1889. During Brother Tuttle's tenure as Pi Kappa Alpha's leader, many of the Fraternity's most important programs were initiated. Brother Tuttle's presidency saw the commissioning of the writing of the first history of the Fraternity, the design and publication of a pledge manual and the authorization of Canadian expansion.

Brother Tuttle's achievements go far beyond the Fraternity though. Appointed to the U.S. Fifth Circuit Court of Appeals in 1954 by President Eisenhower, Judge Tuttle became chief judge of circuit in 1961. During his six years as chief judge, "Tuttle's Court" rendered decisions that changed the life of every Southerner in the six states over which his court held jurisdiction. His court, in Judge Tuttle's words, "did about everything a court can do to vindicate the constitutional rights of black citizens." Chief

Justice Earl Warren said, "Tuttle is one of the great judges of the civil rights era who devoted unending labor to the mountainous tasks of assuring the peaceful, orderly fulfillment under law of the promise of racial equality."

Judge Tuttle's belief in the absolute equality of human beings influences his perception of the Fraternity as well. At a Fraternity event in his honor in 1967 Judge Tuttle said, "Everything in education should train men and women to break down the barriers that separate people, whether barriers of economics, race, denomination; all are artificial if man is truly a brotherhood."

Although Judge Tuttle stepped down as chief judge in 1968, he has remained on the bench for more than two decades as a senior circuit judge. When Judge Tuttle retires as a sitting judge at the end of August he will leave his office in the Elbert P. Tuttle U.S. Court of Appeals building. The building which houses the 11th Circuit Court of Appeals was renamed for him in June of 1990. As is the case with each inductee of the Order of West Range, it is impossible to cover all of Brother Tuttle's contributions to the Fraternity and the legal profession in the limited space of this article. Suffice it to say that Brother Elbert P. Tuttle is an important part of the social and judicial history of this country and an even more important part of the history of Pi Kappa Alpha. He is a perfect example of the statesman rendering service to community, country and fraternity that the Order of West Range seeks to recognize and reward.

THOMAS L. WILLIAMS, JR.

Alpha Alpha '32

The story of Thomas L. Williams, Jr., is the classic story of one young man's idea, conceived in a moment of inspiration, made even better by another man's ingenuity, hard work and intelligence.

A 1932 initiate of Pi Kappa Alpha's Alpha Alpha Chapter at Duke University, Brother Williams showed his ability to accomplish great things at an early age. As a high school student, he was selected as a Kentucky All-State football player. Choosing to commit himself to high achievement in the classroom and chapter room, Brother Williams enrolled in Duke University. As an undergraduate, Brother Williams ascended to the high office of SMC.

Upon graduation, Brother Williams joined Maybelline Cosmetics, the business

founded by his father. Under Brother Williams's leadership, the company named for his Aunt Mabel — who inspired his father's creation of Lash-Brow-Ine, the product that started the company — became a major force in the cosmetics industry. Pioneering the use of mass advertising, especially television in the 1950s, Maybelline experienced incredible success and growth under the leadership of Brother Williams.

Maybelline's current stature in the cosmetics world is the result of Brother Williams's direction in the 1950s and 1960s. These two decades were marked by innovation and aggressive growth. Among Maybelline's "firsts" during this time were carded merchandise, improved self-service racks and the introduction of a four-step coordinated eye make-up "system".

Throughout his life, Thomas L. Williams, who was named a Kentucky Colonel, was a very private gentleman. His wife, Marguerite, said, "His character was his finest attribute. Any who knew or worked with him would agree with that." That is an attribute that any young man aspiring to be a gentleman and a true Pike would do well to emulate. The Pi Kappa Alpha Educational Foundation draped the medal of the Order of West Range over the neck of Brother Williams's wife during the Atlanta Area Alumni Club's Founders Day celebration. This posthumous induction was in recognition of Brother Williams's life of excellence, honor and commitment to his family, his profession and his Fraternity.

LOUIS H. WILSON, JR.

Alpha Iota '39

Shortly after he was sworn in as the 26th Commandant of the United States Marine Corps, General Louis H. Wilson issued a simple statement of purpose. This statement outlined his basic goals concerning the Corps' combat readiness, quality and individual quality. He closed this statement by saying, "I do not believe in magic solutions to problems. Instead, I believe in steady, tenacious progress on all fronts through concerted effort by all hands." This straight-forward, team-oriented approach defined the experience of Pi Kappa Alpha's only Congressional Medal of Honor winner.

Brother Wilson received a regular commission in the USMC after his graduation from Millsaps College in 1941. It was not long before Brother Wilson distinguished himself as a hero. His Medal of Honor citation reads, "...as Commanding Officer of Company F...in action against enemy Japanese forces at Fonte Hill, Guam...July

25 and 26, 1944... Captain Wilson initiated his attack in mid-afternoon, pushed up the rugged, open terrain against terrific machine-gun and rifle fire for 300 yards and fully captured his objective. Promptly assuming command of other disorganized units... he organized his night defenses in face of continuous hostile fire and, although wounded three times during the five-hour period, completed his disposition of men and guns before retiring to the company command post for medical attention. Shortly thereafter... he voluntarily rejoined his besieged units and repeatedly exposed himself to the merciless hail of shrapnel and bullets, dashing fifty yards into the open... to rescue a wounded Marine... Fighting fiercely in hand-to-hand encounters, he led his men in furiously waged battle for approximately ten hours... Brother Wilson captured the vital ground only after leading his men in intense combat that lasted over twenty-four hours. In a much more peaceful moment, on the White House lawn on October 5, 1945, President Harry S. Truman pinned the Congressional Medal of Honor on Captain Louis H. Wilson.

Three decades later another President took notice of Brother Wilson's uncommon abilities. On July 1, 1975, President Ford promoted then Lt. General Wilson, commander of the Fleet Marine Force, Pacific, to General Wilson, Commandant of the United States Marine Corps. Upon his retirement from the Corps in 1979, General Wilson was awarded the Defense Distinguished Service Medal (First Oak Leaf Cluster) for "exceptionally distinguished service" during his thirty-eight year career as a Marine and for four years as the Marine's highest ranking officer and member of the Joint Chiefs of Staff.

The Order of West Range medal presented to General Louis H. Wilson, USMC (Retired), honored a man who had been much honored previously by his country, his alma mater and his Fraternity.

Is Our Fratern

Over the past two years Pi Kappa Alpha has had no alternative than to close seven chapters because of behavioral problems. These reasons include alleged incidents of date rape, problems stemming from parties in which alcohol was overused, apparent drug usage, and hazing.

Like many other national fraternities, Pi Kappa Alpha's Supreme Council (Board of Directors) and professional staff have taken a strong stance in dealing with chapters which violate state and/or federal laws, university and/or college policies, and the laws and policies which govern the national fraternity. Although Pi Kappa Alpha is not in the business of closing chapters it will not hesitate to revoke a chapter's charter if actions of the chapter or any of its members warrant such sanctions.

On campuses across the country fraternities are in the position to either clean up their acts or cease to exist. Faculty members, administrators, and members of the community have long been tolerant of the sometimes childish behavior exhibited by fraternity men. However, in many instances their tolerance levels have been "surpassed".

Already, several colleges in the northeast have withdrawn institutional recognition of their Greek systems during the past decade. Colleges that have withdrawn recognition include Gustavus Adolphus, Amherst, Colby, Williams, and Franklin and Marshall. (Pi Kappa Alpha did not have a chapter on any of these campuses.)

Each of these colleges reported that they studied their Greek systems before rendering a decision. Franklin and Marshall spent three years reviewing the fraternity and sorority practices on its campus. In the Board of Trustees' announcement to ban the Greek system it said an attempt "to upgrade the Greek system, had not succeeded and that the benefits of the Greek system are far from being achieved."

In a written report, Franklin and Marshall's Board also cited other reasons for its decision to ban fraternities and sororities. Among them:

- Fraternities are dangerous, with several Greek-related activities leading to several deaths a year nationally; and
- Fraternities subject colleges to "unacceptable legal risk." The Trustees could not be certain that the college can be adequately protected in the case of a major lawsuit involving death or serious accident in a college-related fraternity.

Many national fraternity officials are fearful that other colleges and universities will take a closer look at their Greek systems and consider similar action. All of this, coupled with the rising cost of liability insurance, has created a movement among all national fraternities to look within their organizations and begin a massive clean-up effort.

As many national fraternity officials point out, the only solution to the problem is to continually provide educational opportunities to undergraduate members on how to deal with the problems they face on campus. Like its counterparts, Pi Kappa Alpha spends thousands of dollars annually to conduct educational seminars at regional and national conferences. Unfortunately, it continues to be forced to close chapters or render disciplinary action to chapters and undergraduate members.

"Ninety-five percent of the time the problem doesn't lie with the whole chapter," says Pi Kappa Alpha's Executive Vice President Ray Orians, "It's the actions of a few which end up costing the chapter and all of its members."

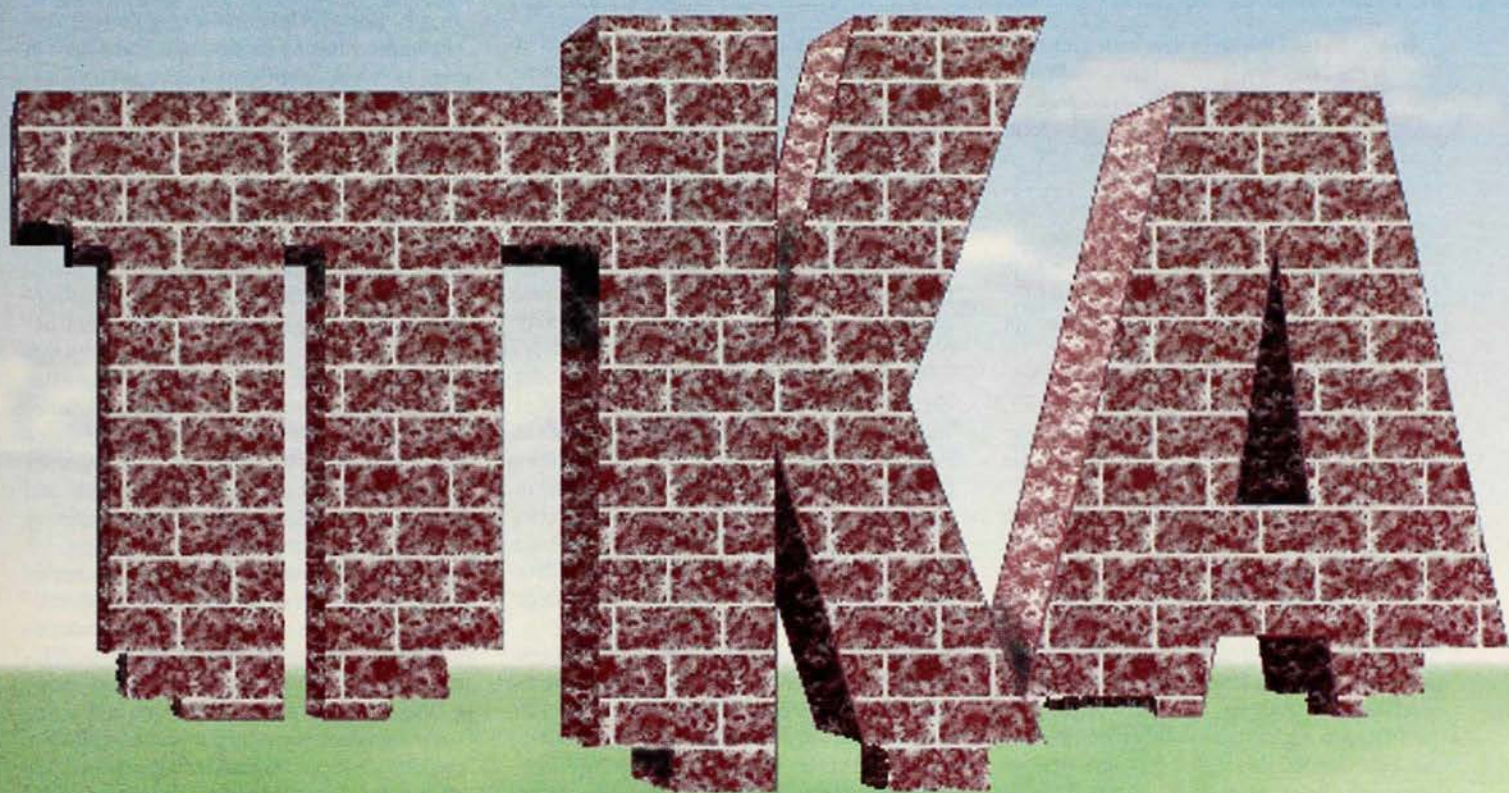
"We know that we can't formally educate each member of the Fraternity, so our educational programs are designed to assist chapter officers on how to recognize potential problems and then how to deal with those problems," Orians notes.

Each national fraternity, its officers and staff members, work together with fraternity advisors and deans in an attempt to reach as many undergraduates as possible. In this effort campus interfraternity councils are encouraged to

sponsor seminars on topics such as date rape, drug and alcohol abuse, hazing, and risk management.

Over the last two years the topic dominating most fraternity and sorority conferences is date rape.

For many the question still is *What is Date Rape?*

Fraternity chapter houses have long been recognized as "bastions for libations" on college campuses where alcohol was not permitted, particularly among underage college students. This era is coming to an end...

To understand the term date rape let's first look at the common legal definition of rape: rape is when one individual forces another individual to have sexual intercourse. The term date rape is used when the victim has held an ongoing social relationship with the attacker.

College officials report that incidents of date rape are on the rise on campuses across the country. Date rape isn't new, it's been occurring on campuses and in fraternity houses for years. However, today's women are more apt to report the crime to the police.

Date rape isn't confined to fraternity houses. Date rape occurs in residence halls. However, fraternities tend to be a focal point in discussions about date rape because of their all-male composition.

Two Pi Kappa Alpha chapters closed in the last two years for continual behavioral problems had allegations of rape filed against them in 1988. Both incidents received tremendous amounts of coverage in the media. The cost to the Fraternity — in real dollars and in reputation — at both the national level and the local level was tremendous.

"Pi Kappa Alpha isn't the only fraternity that has experienced this problem," says Bridget Guernsey, the assistant director of student activities at the University of Pittsburgh and former president of the Association of Fraternity Advisors.

"Date rape is a concern on every college campus and in every Greek system," she reports. "Our only chance to minimize this problem is through education."

According to Guernsey, undergraduates are being taught how to prevent date rape from occurring.

"Women are being taught how to stay out of, or recognize situations where date rape is likely to occur," she points out, "Meanwhile, men, as well as women, are being taught to take action if they see a situation which they believe could lead to date rape."

While Guernsey admits that date rape is not just a fraternity problem, she adds there is a better chance of reaching undergraduates about

date rape prevention when they are members of fraternities and sororities versus any other groups on campus.

"Fraternities and sororities can mandate that their members attend educational seminars on this issue and others," she says, "It's difficult to do this with undergraduates who live in the residence halls."

Guernsey believes that the increased awareness in legal liabilities and the recent emphasis by national fraternities on moral and ethical behavior have helped make a significant impact on this problem.

"Unfortunately, date rape usually occurs when an individual has been drinking too much. So, not only is it important to continue to educate undergraduates about date rape, but there must be a continued push to curb alcohol abuse by individuals and within fraternity houses," Guernsey stresses.

Alcohol use and abuse continues to be a chronic fraternity problem. But, national fraternities are making a significant impact in this area by adopting stricter rules and policies regarding the purchase and distribution of alcohol by chapters and their members. In conjunction, many colleges and universities are adopting and enforcing tougher policies regarding the use of alcohol on college campuses.

Fraternity chapter houses have long been recognized as "bastions for libations" on college campuses where alcohol was not permitted, particularly among underage college students. This era is coming to an end as fraternity chapters are living with new policies regarding alcohol and tougher penalties if they violate those policies.

Some new policies fraternity men are learning to live with include:

- A mandate that chapter funds may not be used to purchase alcoholic beverages;
- Elimination of traditional *all-campus parties*;
- Non-alcoholic or *dry* rush parties; and
- Alcohol cannot be served in *keg-sized* quantities.

Many of these new rules were adopted because of the inability of all national fraternities to purchase liability insurance for themselves and their chapters. A recent ranking of the top thirty high risk groups published by the

insurance industry places college fraternities and sororities at number six, behind (1) bars; (2) liquor stores; (3) child care centers; (4) asbestos contractors; and (5) hazardous waste disposal companies.

Pi Kappa Alpha's most recent annual report (September 1990) stated that between July 1, 1987 to June 30, 1990 our chapters reported over one hundred incidents. During that time forty-five claims were made, and insurance losses equalled \$654,000. The annual report also indicates that approximately seventy-five percent of all incidents were related to alcohol or drug abuse.

Like date rape, alcohol abuse is not new to the campus scene. It, too, has been around for years. However, together with the increase in lawsuits and society's escalating intolerance of alcohol-related problems during the 1980s, drinking by fraternity and sorority members has received more attention on college campuses.

While the two problems mentioned above are relatively "new" to news headlines involving Pi Kappa Alpha and the college fraternity system, hazing continues to grab the front page of newspapers across the country.

The subject of hazing, and the ensuing question on how to eliminate it from the fraternity system continues to be discussed. A comprehensive article on hazing is not complete without a quote or two from Eileen Stevens, chairman of C.H.U.C.K. — the Committee to Halt Useless College Killings.

Stevens' son, Chuck, was killed in a college fraternity hazing incident in 1978. After her son's death, she began a one-person campaign to help bring an end to hazing on college campuses. Her persistence, fortitude, and desire to address this issue caught on quickly. Since her son's death, she has been invited to speak against hazing at 525 college campuses, and has also addressed several national fraternity and sorority conventions.

"When I first started, hazing was frequently brushed under the carpet or dealt with 'quietly' on college campuses by both administrations and national fraternity offices," she notes. "Today, hazing is being dealt with out in the open."

"National fraternities will not tolerate hazing in their chapters anymore," she adds. "They're yanking charters and rendering severe disciplinary action against those chapters involved in hazing."

Stevens' impact against hazing can be measured by the number of states which now have laws which make hazing illegal.

"When Chuck died, only three states had laws against hazing," she says, "Over the last twelve years, thirty-two other states have passed legislation making hazing illegal. I've testified in favor of anti-hazing legislation in several of those states."

"These state laws act as a powerful deterrent to hazing, and they also strengthen a college, university, and/or national fraternity's position against hazing," Stevens says. "However, this hasn't made hazing go away. They are strong and aggressive steps in the right direction, but they aren't enough."

During the last decade Stevens reports there were fifty hazing-related deaths. She is quick

to mention however, that this figure is not accurate.

"There have been many other hazing-related deaths, but because of circumstances they aren't reported as such," she notes. "It's the same with injuries caused by hazing. Many people are injured — and injured seriously — in hazing pranks each year. However, many times the injured party doesn't come forward."

Stevens admits there isn't a simple answer to getting rid of hazing, but does mention all of the educational programming national fraternities sponsor at their regional and national conferences is a major step.

"Recently a few national fraternities eliminated the 'traditional' pledge programs within their chapters, and several others are considering doing the same thing," she reports, "I don't see this step as a cure-all, but I admire and support any effort to rid the system of hazing."

Stevens is pleased with the response and support she has received over the years. Her biggest supporters, she says, are fraternity and sorority members.

"Ninety-nine percent of the invitations I receive to speak on college campuses come from undergraduate fraternity and sorority members. I think this is because hazing is viewed as one of the issues which can cause the demise of the Greek system and people are concerned," she emphasizes. "I believe in the Greek system. Many people mistake me for being anti-Greek because I speak out against hazing. That's not true."

Fraternities are truly under a lot of fire lately. The Greek system has undergone many changes over the last two years, and it will have to continue to change in order to survive. The changes will be many. The experts tell us that better education of our undergraduates will facilitate the necessary changes.

Historically, Pi Kappa Alpha has contributed to the informal education of its members in the areas of leadership development and community responsibility. The Fraternity now finds itself obligated to be a more formal participant in the educational process of its undergraduates, teaching ethics and values, appreciation of cultural diversity, respect for the dignity of women, and other important components of individual and professional development. This is not an option or alternative for the national Fraternity — it is a must.

Pi Kappa Alpha experienced tremendous growth during the Seventies, and Pi Kappa Alpha thrived in the Eighties. Its undergraduate membership rose from just over 10,000 undergraduate members annually in 1980, to well over 14,000 by the end of the decade. Pi Kappa Alpha also installed twenty-five new chapters during the decade. Times were good for our Fraternity. The foundation for the Nineties seemed solid.

But in two short years, Pi Kappa Alpha has closed nearly a third of the number of chapters it opened in the 1980s. Is the foundation we built for our Fraternity crumbling away?

A close examination will show that the foundation isn't crumbling away. Pi Kappa Alpha has always been able to face and over-

come adversity when the existence of the Fraternity has been threatened. Pi Kappa Alpha's foundation, and ultimately its strength, is not in its chapters, nor is it represented by an impressive building in Memphis, Tennessee. In the wake of challenges, it is our alumni corps who chose to continue their fraternity involvement as volunteers and financial contributors who are the Fraternity's foundation.

Today, over 1,200 alumni are involved in the battle to educate our undergraduates and assist them in becoming responsible adults.

Can we educate our members and prevent them, and ultimately our chapters, from falling victim to the perils of date rape, hazing and alcohol or drug abuse?

Pi Kappa Alpha believes so. Each year the Fraternity sponsors sixteen regional leadership conferences for its undergraduate members. These two-day conferences address the issues of risk management, date rape, hazing, and drug and alcohol abuse through seminars. The Fraternity recruits outside speakers, national officers and its professional staff to lead these educational sessions.

In addition, the Fraternity's chapter consultants are educated in these areas and work with chapter officers, committee chairmen and individual members during their visits throughout the school year.

Pi Kappa Alpha has also published a comprehensive collection of publications and brochures which are available to the chapters to use as educational material with their members and pledges.

"It's difficult to know exactly what the long term effect these programs will have on our undergraduate members," says Executive Vice President Orians. "But I can report there have been only had seven claims against the Fraternity during the past school year — all of which have been minor — and the total reserve for all of those claims is \$9,000. I believe this is evidence that our educational programs are working."

For many, this raises the question: Should Pi Kappa Alpha be in the business of educating men who are responsible citizens? The Fraternity's preamble and ritual indicate that has always been one of our objectives. The time has come for each member of the Fraternity — alumnus and undergraduate alike — to fully recognize our original *raison d'être* and help to fulfill our role in the total development of our members. Hopefully we will produce individuals who are true to the ideals we espouse, and the threat to our existence will be lessened and maybe even eradicated.

Whatever the answers to these questions might be, one thing is for sure, and that is never at anytime have the words penned by Pi Kappa Alpha's late Executive Director Robert D. Lynn (*Mu '34*) ever rung so true:

*Yesterday is Gone Forever
Tomorrow is Yet to Be,
The Destiny of Pi Kappa Alpha,
Rests Today with Thee.*

Alumni Fulfill The Commitment 'Once A Pike, Always A Pike'

What do a United States Senator, a pharmacist, a doctor, a dentist, a retired Air Force lieutenant colonel, and a banker have in common? They are all Pi Kappa Alpha alumni who hold or have held volunteer positions with the Fraternity.

Why would these individuals, who are among more than 1,000 alumnus brothers, continue their involvement with the Fraternity following graduation, particularly when they have family and professional concerns which also demand their time? The answers are many, but practically all alumnus volunteers respond with the identical theme of wanting to give back to something from which they received so much.

Perhaps Pi Kappa Alpha's national president, Dr. Jerry Askew (*North Carolina - Tau '73*), says it best: "I've said it many times before. You cannot pay back. You need to pay forward."

Brother Askew, who held several volunteer positions and offices prior to his election as national president at the 1990 Chicago Convention, believes that "the primary reason to volunteer is when one was initiated into the

Fraternity, one promised to be a zealous member for life."

"It's an obligation we took," he says. "We need to fulfill that commitment. We owe a great deal to all those who came before us. We owe it to them to provide that same opportunity to those who follow us."

"Once a Pike, Always A Pike."

From among the many mottos that the Fraternity has had over the decades, this one undoubtedly is one of the most important and certainly has infinite meaning. Alumni of the Fraternity have always played and continue to play a vital role in Pi Kappa Alpha.

The first alumni of the Fraternity were the original founders, and beginning with the founders, alumni of Pi Kappa Alpha have always played important leadership roles, from positions on the local chapter level to elected and appointed officers for the National Fraternity.

Undoubtedly one of the most dedicated alumni in the Fraternity's history was Robert Adger Smythe, who served IKA for 72 years.

Many alumni get involved immediately after graduation from college. Others return after establishing careers and families. There are many positions in the Fraternity which require

and need alumnus volunteers, including chapter advisors, alumni associations, house corporations, chapter advisory boards, chapter receivership boards, and regional and national officers, the latter of which are volunteer elected or appointed positions.

Take Woody Bentley, for example. The 1958 initiate of Epsilon Alpha chapter (*Trinity College*) left college to join the Air Force, but later returned to George Washington University where he affiliated with Delta Alpha chapter and completed his degree. He relocated to North Dakota and served as the colony advisor for Zeta Rho chapter and became its chapter advisor following installation. He served the National Fraternity as a regional vice president under the Fraternity's old structure in the late 1960s.

"It is as enjoyable as an adult advisor as it was as a youth member," says Bentley. "It is good to put a focus on the opportunity to continue your association with the university and college age youth, particularly your Fraternity brothers, and all they stand for."

Brother Bentley is still involved and is back at Delta Alpha (which fell silent in 1965 but was re-chartered in 1991) as chapter advisor. "If you believe in the Fraternity's ideals and the importance of helping youth recognize what those ideals mean, and can translate that into real life solutions, then there is no better place to invest your time than working with these college-aged young men," he says. Bentley, a retired Air Force lieutenant colonel, works as a security consultant in the Washington, D.C. area.

U.S. Senator Thad Cochran (*Mississippi State - Gamma Iota '56*) found time along with his many official duties to serve the Fraternity as a trustee of the Memorial Foundation (now the Educational Foundation) during 1979-80. He also served as the honorary chairman for the Campaign for Pi Kappa Alpha.

Many alumni agree that perhaps the most rewarding, yet challenging position with the Fraternity is that of chapter advisor. This individual has a myriad of responsibilities and duties and is the one who sometimes gets the 3:00 a.m. call saying that something has happened at the chapter house.

One person already used to such early morning calls is Dr. Ray Jenkins (*Texas - Beta Mu '54*), a radiology physician. Dr. Jenkins serves as Eta Upsilon (*Texas at Arlington*) chapter advisor. He previously served Beta Mu as chapter advisor and served on its house corporation. Why does he stay involved?

"I felt I got a lot out of it and wanted to give something back. I enjoy working with young people. People say I'm crazy for working with

a college fraternity, and I say, 'Yeah, but it's the same as working with the Boy Scouts or any similar organization.' It's an important age group with which to work," Brother Jenkins says.

Dr. Jenkins says that his involvement gives him a real change of pace from his daily medical routine. "I get personal gratification from it. I get to teach young men to be good citizens, individually and collectively."

Even though he admits there is frustration because he feels like he has to reinvent the wheel every semester, Brother Jenkins encourages more alumni to get involved with local chapters. "Coming from a small town to a big university as I did, the Fraternity did a lot for me. My involvement is payment for what it did for me," he adds.

One of Dr. Jenkins' highlights as chapter advisor came when his son was pledged and initiated into Eta Upsilon. Brother Jenkins was named Pi Kappa Alpha's Chapter Advisor of the Year in 1989.

Virgil McBroom was initiated into Beta Eta chapter (*Illinois*) in 1925. He later established a successful savings and loan association. Fifty-five years later, Brother McBroom was elected the Fraternity's national president.

Brother McBroom got active as soon as he was graduated when he became president of Beta Eta's alumni association. He was later recruited to become district president by then National President Charlie Freeman. He also served on the Housing Commission, chaired the Real Estate Commission, was elected a vice president on the Supreme Council, and then served as president from 1980 to 1982.

Why does he stay involved? "It keeps me young," he laughs. "I love it. I love associating with young people. It's a way of life that they need. It helps them grow into manhood and

tenure, and colony advisor for the Fraternity's new group of over sixty men at St. Joseph's University in Philadelphia.

"I got a lot from the Fraternity as an undergraduate and now I want to give something back," he says. Although he laughingly admits that there are times when he gets headaches and ulcers from working with the two groups, he admits his involvement makes him feel good. "It keeps me active. I think the chapters need guidance from someone who has had the experience of being in the Fraternity."

Brother Goldstein, who says he plans to stay involved as long as he can devote the necessary time, encourages other alumni to get involved with ΠΚΑ chapters. "I really enjoy it. When you're an undergraduate, you really don't get to do all the things that you want to do. As an advisor, I have the opportunity to do those things with the undergraduates that I didn't have the chance to do in my chapter."

Last October, Dick Russell (*Purdue - Beta Phi '56*) completed twenty years of service on the Home Association for his chapter, sixteen of which were as its president.

Brother Russell says that he stayed involved because he is a strong proponent of the belief that young people are the decision makers of tomorrow, "and if we can leave anything to our future, it is to help prepare the younger generation to deal with society, to deal with their responsibilities in the work place and in the social society that exists today."

Russell, who is the executive director and CEO of the Indiana-Kentucky Hardware Association, also has a son who is a Pike. He adds, "It (involvement) is to help young men prepare for the future. That is what alumni can contribute. My philosophy is that if you got something out of it as a young man, you have an obligation to put something back into it.

it gives him a release from work and exposes him to a totally different bunch of people with which to work.

Another of the senior members in the volunteer ranks is Joe Pavelka (*Nebraska - Gamma Beta '34*). The retired banker lives in Arlington, Virginia and divides his time between assisting Delta Alpha (*George Washington*), Delta Psi (*Maryland*), and Delta Eta (*Delaware*) chapters. He has been president of the Washington, D.C. Alumni Association since 1972. This position involves planning the annually successful Congressional Founders Day, which draws many of ΠΚΑ's congressmen and senators.

What does Brother Pavelka get out of his heavy involvement? "The late Brother John Horne (*Alabama - Gamma Alpha '33*) said at a Congressional Founders Day that you get more out of the Fraternity than you put in. I get more back than the time I put into it," he says. He adds that he has no family, so the Fraternity has become his family.

Undoubtedly the thousands of alumni who have been or are involved as volunteers have different and varying reasons for staying active with Pi Kappa Alpha. There are others who have served and currently serve as professional staff members at the Fraternity's national headquarters in Memphis. Many volunteer alumni were once members of the professional staff, and among them is Indiana State Senator Ed Pease (*Indiana - Delta Xi '71*).

Brother Pease's dedication to the Fraternity was evidenced in 1974 when he took a leave of absence from law school to work for a year as the director of alumni affairs at the Memorial Headquarters. After he left the staff, he served as Midwest regional president, chair of the Alumni Commission, Hoosier Alumni Association president, colony and chapter

prepares them for business in the outside world."

How did he find the time with his business and family commitments? "I was fortunate to have good employees and did most of the work on the weekends. It didn't take away from business. I am a great believer in fraternities."

Brother McBroom, who also has a son who is a Pike, remains active with the Fraternity as well as with his condominium association at his home in Pompano Beach, Florida.

Dr. Howard Goldstein was graduated a mere eight years ago from Lehigh University, where he was a member of Gamma Lambda chapter. Since graduation he has completed his dental studies and established a private practice, and he has not taken a breather from his involvement with the Fraternity. He serves as the chapter advisor for Theta Chi (*Villanova*), which has won two Smythe Awards under his

If it was meaningful and left you with strong feelings in regard to the things that the Fraternity stands for, you have the obligation to give back as adult alumni."

Al Ross (*Washington - Beta Beta '59*) has served his chapter as advisor for the past eleven years. A pharmacist, Brother Ross got involved as an alumnus because he became interested in seeing his chapter rechartered since it fell silent in 1970. Beta Beta was rechartered in 1980 with Brother Ross as advisor.

He believes that alumni should stay involved because of the many talents and abilities they have to offer undergraduates. "The students need their help. Alumni need to see that the younger generation is not as bad as people make them out to be. There is a lot of talent and ability among the undergraduates, too, that need to be directed."

advisor for Theta Omicron (*Indiana State*) (which has won more Smythe Awards than any ΠΚΑ chapter), two terms as national vice president, and as national president from 1988 to 1990. Following completion of his term as national president, he returned to his position as Theta Omicron's chapter advisor.

"I had a good experience as an undergraduate," says Brother Pease. "I was one of the guys who had his life changed by the experience. The Fraternity opened many doors for me both in terms of personal growth and leadership opportunities. I've wanted to give something back."

Interestingly enough, Senator Pease says that he finds that the more he tries to pay back, the deeper in debt he gets because he is still getting positive experience as an alumnus volunteer. "It all goes in cycles," he laughs.

Brother Pease stresses that undergraduates need adult role models to work with them during this important period in their lives. What does he get out of it? "The satisfaction of seeing men who share my principles grow and develop because of their association with ΠΚΑ, and to know that I've been a part of helping assist with that growth," he says.

Were it not for alumni, Pi Kappa Alpha most likely would not have survived for over 120 years. And certainly it would not have prospered as it has. Executive Vice President Raymond L. Orians (*Memphis State - Delta Zeta '66*), a former chapter advisor to Delta Zeta chapter, says, "Our chapters that are among the best in the country year after year share the common characteristic of having consistent involvement from alumni. Chapter advisors not only provide assistance with chapter



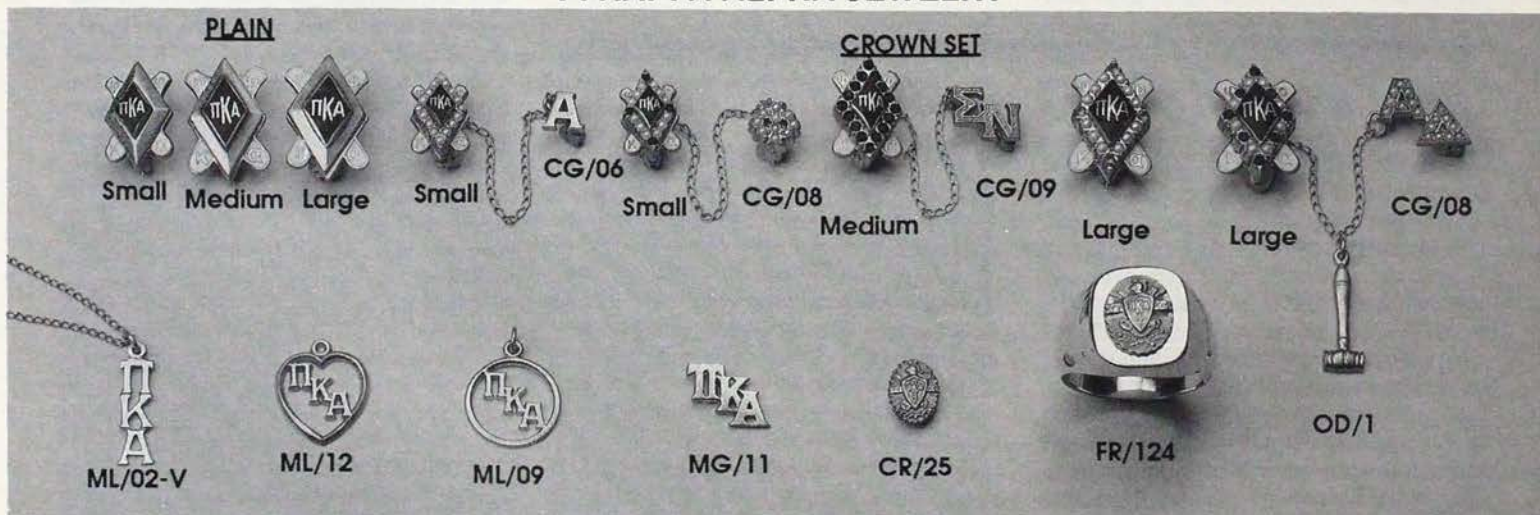
Past National President Edward A. Pease (*Delta Xi '71*) (standing) has spent many years working with Pi Kappa Alpha's undergraduate brothers.

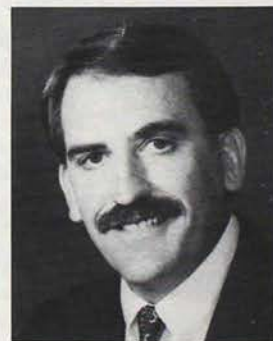

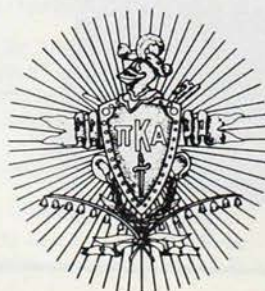

Chapter Eternal

The Pi Kappa Alpha Memorial Headquarters has received notification of the passing of the following brothers into Chapter Eternal:

Richard J. Clarke

Richard J. "Scotty" Clarke, a 1950 initiate of Delta Eta Chapter at the University of Delaware, died at his home in Wilmington, Delaware on April 1, 1991 at the age of 72.

A native of Scotland, Brother Clarke was an avid golfer and bowler. He was a Navy veteran of World War II and graduated from the University of Delaware School of Chemical Engineering in 1952. He devoted more than forty years of membership to Pi Kappa Alpha and was designated as a Life Member of the Board of Trustees of Delta Eta Corporation.

For a number of years, Brother Clarke served as president of the Board. During the lean times in the late 1950s, he often paid installments on the chapter mortgage out of his own pocket. He was named president of the Board of Trustees for the second time in the late 1970s, during the construction and dedication of Delta Eta's present house at 313 Wyoming Road.

Brother Clarke was employed by the DuPont Company in Newport, Delaware until his retirement in 1980. He is survived by his wife, Mrs. Beverly Clarke; a daughter, Diane, and a son, James.

Silvio O. Conte

Rep. Silvio O. Conte, initiated in 1986 by Theta Mu Chapter at the University of Massachusetts, died on February 8, 1991 after undergoing surgery for a blood clot on the brain. He had suffered from cancer for several years.

A liberal Republican who was often at odds with a majority of his GOP colleagues, Brother Conte was the ranking Republican on the Appropriations Committee.

Born on November 9, 1921 in Pittsfield, Massachusetts, Brother Conte earned his law degree from Boston College. He served for eight years in the State Senate before being elected to the House of Representatives in 1958, where he served for 34 years. He was a popular representative, frequently speaking out against wasteful government spending and "pork barrel politics".

The only Republican representative from Massachusetts, he often voted with the Democratic majority, and was a champion of human services funding. Powerful, respected, and unafraid to speak out against those with whom he found fault, Brother Conte was elected seventeen times from Massachusetts' 1st District — seven times

unopposed. Brother Conte is survived by his wife, Corinne, and four children.

Lawrence W. I'Anson

Lawrence W. I'Anson, a 1924 initiate of Gamma Chapter at the College of William and Mary, former chief justice of the Virginia Supreme Court, and a principal advocate of key reforms in the court over the past two decades, died on December 17, 1990 at the age of 83.

Born in Portsmouth, Virginia, Brother I'Anson graduated from the College of William and Mary in 1928, and received his law degree from the University of Virginia in 1931.

Brother I'Anson was appointed to the state Supreme Court of Appeals in 1958 by Governor J. Lindsay Almond, and served on Virginia's highest court for 23 years before his retirement in 1981. For six of those years he was the court's 22nd chief justice. During those years, he said that one of his greatest pleasures in life was working with disadvantaged Portsmouth youth through the philanthropic Beazley Foundation.

In 1971, Brother I'Anson founded the National Center for State Courts and served as its president. He also served as chairman of the National Conference of Chief Justices. He was honored by the American Judicature Society for his court reform work which led to a major reorganization of the state's court system, and in 1973 he received the distinguished service award from the Virginia Trial Lawyers Association.

Survivors include a daughter, Mrs. Peter M. Ramsey of Richmond, and a son, Lawrence W. I'Anson Jr. of Portsmouth, Virginia.

William O'Neil

William P. O'Neil, a 1922 initiate of Zeta Chapter at the University of Tennessee-Knoxville, died on March 17, 1991. He was an attorney in Knoxville, Tennessee, and was recognized by his peers as "one of the last of the great old lawyers".

Brother O'Neil received his law degree in 1927 from UT-Knoxville, and stayed in the eastern Tennessee city to practice his profession. He served as president of the Knoxville Bar Association in 1951-52, and was active in state and national bar associations. He was also a member of the American College of Probate Counsel. In 1975, Brother

O'Neil was one of six area lawyers chosen to have an endowed prize named for him in the appellate moot court competition at the University of Tennessee College of Law.

He is survived by two brothers, Thomas J. O'Neil, Sr. of Knoxville, and George T. O'Neil of Memphis, Tennessee; a daughter, Julie M. Arnheim of Princeton, New Jersey, and three grandchildren.

Caldwell Ragan, Sr.

Caldwell Ragan, Sr., initiated in 1917 by Alpha Delta Chapter at Georgia Institute of Technology, died at his home in Gastonia, North Carolina, on January 19, 1991. He was 92 years old.

A distinguished North Carolina industrialist and textile manufacturer, Brother Ragan began his career in 1915 when he began work at the Groves Thread Mills in Gastonia, where he earned \$4.50 per week. He graduated from Georgia Tech with a textile engineering degree in 1919, and completed a graduate degree at New Bedford Textile Institute in Massachusetts in 1920.

Back in North Carolina in 1923, he organized and built Ragan Spinning Company. He served that company in all executive positions and was president and chief officer from 1936 to 1951. It was a source of pride to him that his company operated successfully and full time during the hard years of the Great Depression, employing many area residents. In 1946, he sold the business to J.P. Stevens & Co., Inc., and the Ragan Plant, located near Bessemer City, NC, operates today as a unit of Stevco Knit Fabrics Company.

In 1953, Brother Ragan became associated with textile industrialist Julius W. Abernathy, Sr. and was elected president, treasurer, and general manager of Trenton Cotton Mills, Inc. When that company merged with Carolina Mills, Inc., he became its executive vice president, a position he held until his retirement in 1965. He served as a director and member of the executive committee of Carolina Mills, Inc. until 1977, when he was elected a director emeritus of that firm, a position he held until the time of his death.

Brother Ragan was a member of one of the South's pioneer textile families. His father, Gen. George Washington Ragan, was one of the leaders in the industrial development of the post-reconstruction "New South", and was instrumental in placing southern textile products in successful competition with those produced in New England.

Among his other distinctions, Brother Ragan was president of the Southern

Combed Yarn Spinners Association (1943-44), director of the American Textile Manufacturers Institute (1944-47), director of the Cotton-Textile Institute of New York (1944-47), director of the North Carolina Textile Manufacturers Association (1945-51), and director of the North Carolina Textile Foundation (1960-66). Additionally, he served as chief of the cotton yarns division, industry operations, of the War Production Board (1942), and was a member of the combed sales yarn industry advisory committee

of the Office of Price Administration in Washington, D.C. (1943-47). From 1948-54 he served on the General Arbitration Council of the National Security Resources Board, and from 1945-47 as a management representative on the Gastonia, NC office of Management-Labor Committee Appeals Panel.

Brother Ragan is survived by two sons, Caldwell Ragan, Jr., and Robert A. Ragan; a daughter, Mrs. Louis L. Rose, Jr.; two sisters and four grandchildren.
